- I. **FUNDING** - The additional funding amount of \$1,000,000.00 (*One Million Dollars*) provided by the ABRAHAMIC TRUST FUND to SMITH CHAPEL APOSTOLIC CHURCH for the express purpose of advancing the Kingdom Agenda of Christ (KAC).
